

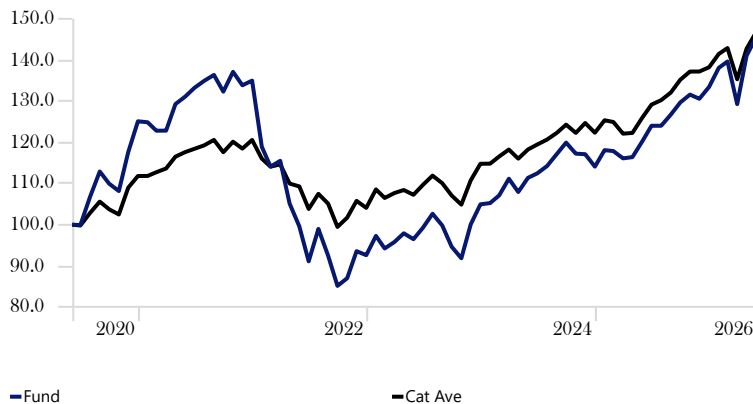

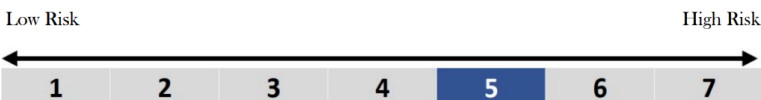

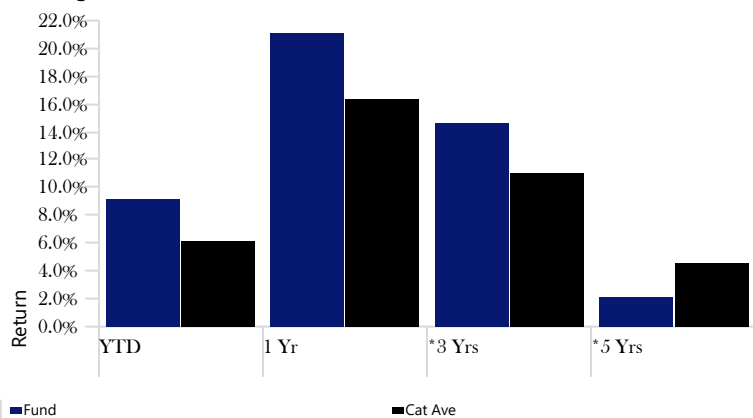
Investment Growth

Portfolio Objective and Strategy

The principal investment objective of the Fund is to achieve medium to long term capital appreciation at the risk of moderate short-term volatility of capital values. The Fund is Diversified CIS designed to maximise returns. It will be diversified across asset classes and regions. The investment objective is to achieve medium to long term capital growth through exposure to selected sectors of the global equity market, bond market and money market.

The Fund is aimed at investors with a medium to long term (4 to 6 years) investment time horizon. This Fund is best suited for investors who can accept some volatile capital movements but seek consistent returns.

Monthly Commentary

The Iza Global Balanced Fund continued its positive momentum in May 2026, delivering a return of 4,39% (GBP) and 3,26% (USD), and extending its year-to-date performance to 9,27% (GBP) and 9,12% (USD). This builds on the strong rebound seen in April, marking a second consecutive month of solid gains following the weakness experienced in March. The Fund outperformed its benchmark, which returned 2,71% (GBP) and 2,80% (USD) in May. This reflects continued strong relative alpha generation, driven primarily by equity market exposure and manager selection.

Performance in May remained broad-based, with global equities again leading returns. Templeton Emerging Markets was the funds standout performer, delivering a meaningful return of 14,98%, reflecting a strong rebound in emerging markets. The continued strength in the global growth stocks drove a solid return of 9,58% from the T.Rowe Price Global Focused Growth Equity Fund. Scottish Mortgage continued its sustained recovery with a positive return of 7,94%, driven by the positive SpaceX IPO noise. The Jupiter Global Equity fund and Nomura Japan Strategic Value Fund continued to positively perform, delivering returns of 6,17% and 6,48% respectively. Our portfolio's core holding in the iShares MSCI World GBP Hedged and iShares MSCI World EUR Hedged continued to deliver a market return of 5,43% and 5,60% respectively.

In May our top contributions to performance were from the Templeton Emerging Markets Fund, which contributed 0.80% and T.Rowe Price which contributed 0.76%. This was in addition to our core in the MSCI World which provided a solid combined return of 0.85%.

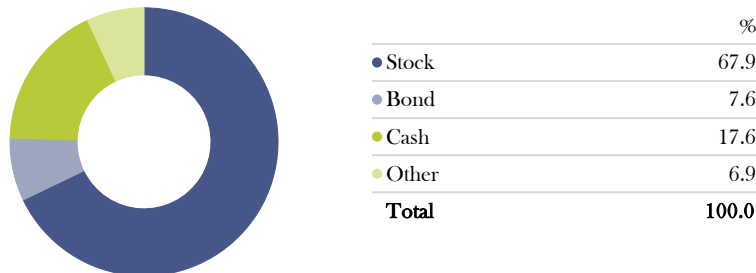

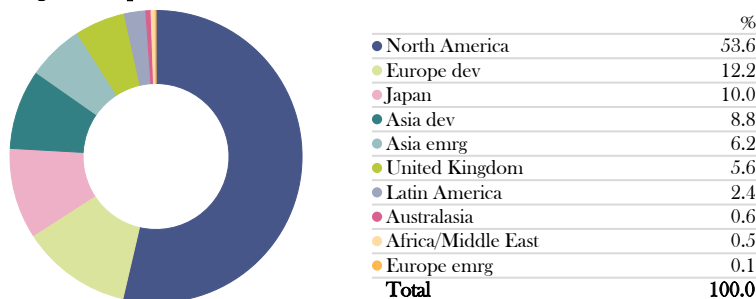

Glossary of Terms

Standard Deviation is a measure of the dispersion of a set of data from its mean. When applied to an annual rate of return it sheds light on the historical volatility of the investment.

Sharpe Ratio is a measure for calculating risk-adjusted return. It is the average return earned in excess of the risk-free rate per unit of total risk.

Maximum Drawdown is the measure of the the maximum observed loss from a peak to trough of a portfolio, before a new peak is attained. It is an indicator of downside risk over a given period.

Sortino Ratio is a measure for calculating the performance of an investment relative to its downside deviation. It is the average return earned in excess of the risk-free rate divided by the investments' downside risk.
