

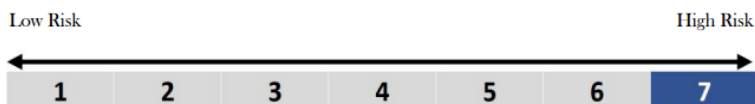

Portfolio Objective and Strategy

The Fund aims to achieve returns in excess of MSCI All Country World Index p.a. over rolling six-year periods. Fund returns will be generated through dividend income and capital growth. The Fund is a multi-manager Fund ideally comprising at least two underlying funds. Fund selection will be bias towards funds with outperformance of benchmark and to managers whose objective is to achieve long term growth. Where possible underlying funds will be given as many of the equity sector allocation decisions as possible. Underlying investments may be denominated in multiple first world currencies; however, all performance and risk statistics will be measured in the applicable currency.

The Fund will, apart from liquid assets, consists of listed equities, bonds, property equity and money-market instruments as well as participatory interests in collective investment schemes, including exchange traded funds ("Collective Investment Schemes").

The Fund is aimed at investors with a long-term (6 years or more) investment time horizon. This Fund is best suited for investors who can accept some volatile capital movements but seek returns in excess of MSCI All Country World Index over rolling 6-year periods.

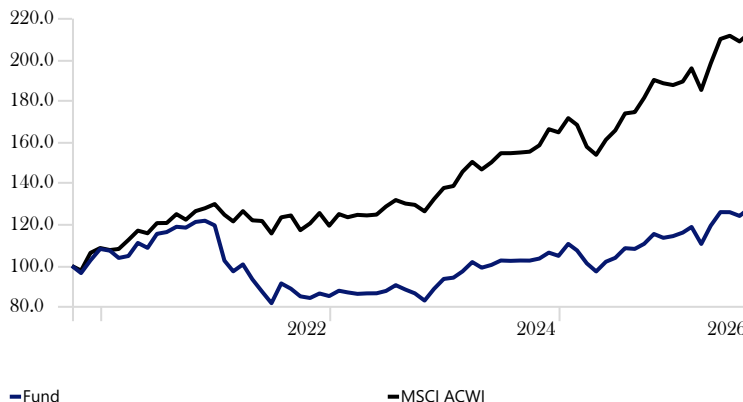
Monthly Commentary

The Iza Global Equity Fund delivered a strong return of 2,99% (GBP) and 3,51% (USD) during August, bringing its year-to-date return to 11,79% (GBP) and 12,42% (USD). The Fund outperformed its benchmark, the MSCI ACWI Index, during the month in both currencies (benchmark returns of 1,91% (GBP) and 2,67% (USD)), though it remains behind on a year-to-date basis (benchmark returns of 12,59% (GBP) and 13,52% (USD)). The Fund has also lagged the benchmark over the one and two year period, with Fund returns of 18,20% (GBP) and 18,61% (USD) over one year (versus benchmark returns of 21,92% (GBP) and 22,35% (USD)) and 24,70% (GBP) and 28,72% (USD) over two years (versus benchmark returns of 37,33% (GBP) and 41,67% (USD)).

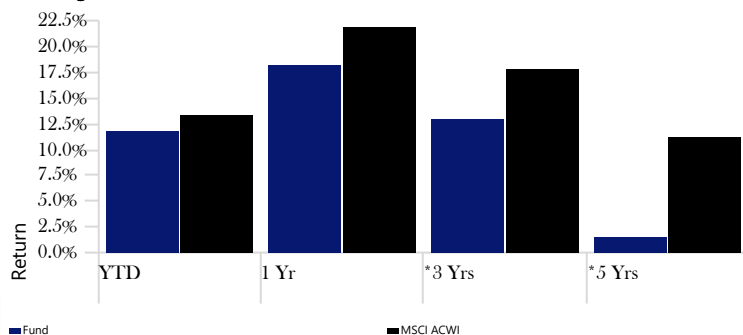
August delivered broad-based gains across the Fund's underlying managers, marking a strong rebound following July's weakness. The strongest performing underlying holdings during the month were Ranmore Global Equity, delivering a positive return of 6,85%, the iShares MSCI World USD allocation, delivering a return of 3,58%, and Jupiter World Equity Fund, delivering a return of 3,39%. There were no material detractors during the month, with every underlying holding posting a flat or positive return; Guinness Global Innovation was the only notable laggard, though it still delivered a positive return of 3,58% relative to its peers.

In August, our top contributions to performance came from the iShares MSCI World USD allocation, which contributed 0,65%, Jupiter World Equity Fund, which contributed 0,49%, and Northstar Global Equity, which contributed 0,42%. With gains broad-based across the portfolio, there were no meaningful detractors to overall contribution during the month.

Glossary of Terms

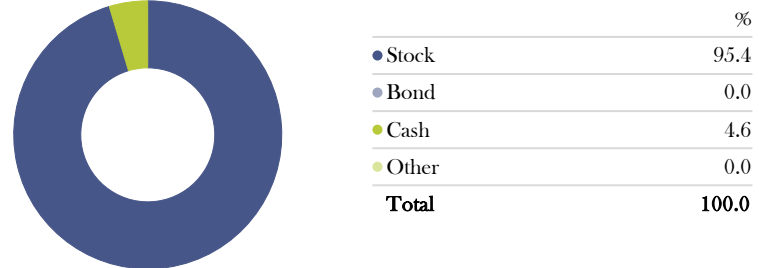
Standard Deviation is a measure of the dispersion of a set of data from its mean. When applied to an annual rate of return it sheds light on the historical volatility of the investment.

Sharpe Ratio is a measure for calculating risk-adjusted return. It is the average return earned in excess of the risk-free rate per unit of total risk.

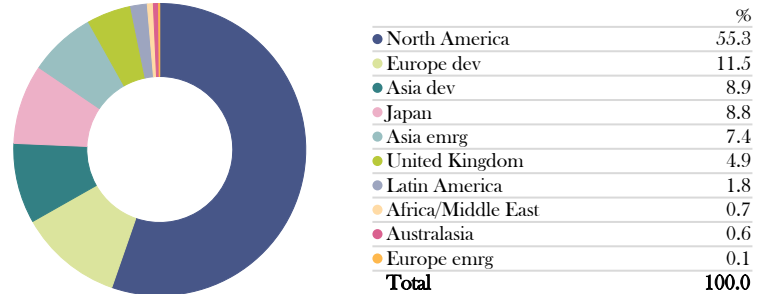
Maximum Drawdown is the is measure of the the maximum observed loss from a peak to trough of a portfolio, before a new peak is attained. It is a an indicator of downside risk over a given period.

Sortino Ratio is a measure for calculating the performance of an investment relative to its downside deviation. It is the average return earned in excess of the risk-free rate divided by the investments' downside risk.
